Bayside Region – Frankston LGA & Mornington Peninsula Shire

Summary

An exciting opportunity exists for a General Practice to partner with the Melbourne Sexual Health Centre (MSHC) and join the Victorian Sexual Health Network (VSHN).

Through this partnership, participating general practices will receive education, mentorship, and ongoing specialist clinical support from MSHC to strengthen the delivery of sexually transmitted infection (STI) testing and management within primary care.

This Expression of Interest (EOI) outlines the partnership model and provides an overview of the Victorian Sexual Health Network.

Background

In 2019, the Victorian Department of Health released a review of state-wide sexual health services, recommending a decentralised '**hub and spoke**' model of care delivery. Under this model:

- MSHC functions as the specialist hub
- Participating general practices act as community-based spokes

MSHC provides clinical education, mentoring, and ongoing support to enable GP practices to deliver high-quality, sustainable STI testing and treatment services within primary care settings.

Eligible practices are located in priority areas with higher rates of STIs, and the model supports embedding practice nurses alongside GPs to ensure continuity and sustainability of care.

MSHC currently partners with ten GP practices across Victoria through this initiative, collectively known as the **Victorian Sexual Health Network (VSHN)**.

Evaluation of the program has demonstrated:

- Increased STI testing and treatment
- High levels of patient satisfaction

What MSHC Will Provide

The successful practice will receive:

- Comprehensive education and onboarding, delivered by MSHC clinical educators
- Ongoing clinical mentorship and support
- Training covering all common STI syndromes and inclusive care, including:
 - HIV PEP and PrEP
 - Mpox
 - Sex Worker Affirmative Practice
 - Gender Diversity
- Education delivered via a combination of:
 - Virtual presentations (Microsoft Teams)
 - Face-to-face sessions
- Clinical placements at MSHC, open to medical, nursing, and administrative staff
 - **Financial support is provided to cover staff time away from the practice**
- Regular meetings with:
 - Practice Manager
(weekly during onboarding; monthly post-launch)
 - Identified practice champions
- Access to real-time specialist clinical advice via the MSHC GP Support Phone Line
(Monday–Friday, 9:00–12:30 and 1:30–5:00)
- Co-branding on MSHC and Stay STI Free websites
- Marketing and promotion of your practice as a VSHN partner

The onboarding and development phase typically takes **6–8 weeks**.

Financial Support

- **\$5,000 onboarding and launch payment**
(upon completion of MSHC milestones)

Eligibility Criteria

To be eligible, the practice must:

- Be located in **Frankston LGA or Mornington Peninsula Shire**
- Commit to a long-term partnership with MSHC
- Hold current RACGP accreditation
- Be available to commence onboarding from **May 2026**
- Agree to participate in ACCESS (Australian Collaboration for Coordinated Enhanced Sentinel Surveillance of STIs and BBVs) for de-identified data sharing
 - Data shared with MSHC and the Victorian Department of Health
- Allocate sufficient staff time for education, training, and ongoing participation
- Provide onsite injectable treatment for gonorrhoea and syphilis
- Nominate a partner pharmacy to supply antibiotics and HIV prevention medications (PEP and PrEP)
- Nominate:
 - A **GP Champion**
 - A **Nurse Champion**
 - An **Administration Champion** *(with the Practice Manager as the key coordinating contact)*
- Ensure the Principal GP actively supports and promotes the sexual health service
- Accept that the partnership may be discontinued if training or reporting requirements are not met
